



### 2023 SHORT PROJECT AGREEMENT Minimum Deferred Compensation

As set forth in Section 3 of the Short Project Agreement (“Agreement”), **initial compensation and salary are subject to good faith negotiation between the Producer and the individual Performer or Background Actor.** Stunt Coordinator rates for Daily, Weekly and “Flat Deal” Stunt Coordinators track the rates in Schedule K-I, K-II or K-III of the Basic Agreement that are current at the time of photography.

If the project is released to a Subsequent Use market, all deferred compensation must be paid. For Principal Performers, deferred compensation under this Agreement for this purpose may not be less than 20% of the applicable day rate from the Basic Agreement current at the time of performance per day for Principal Performers. For Background Actors, deferred compensation under this Agreement for this purpose may not be less than 75% of the applicable day rate from the Basic Agreement current at the time of performance per day for Background Actors.

In the event of a conflict between the below rate sheet and the Agreement, the Agreement shall govern.
