CALLING ALL CANDIDATES

SAN FRANCISCO-NORTHERN CALIFORNIA LOCAL ELECTIONS

This year, the SAG-AFTRA San Francisco-Northern California Local will hold elections for the following National Board, Local Officer, Local Board and Convention Delegate positions:

National Board Member – Broadcast*	4-year term
President	2-year term
Vice President – Broadcast*	2-year term
Vice President – Performer*	2-year term
Recording Secretary	2-year term
Two (2) Local Board Members – Broadcast*	2-year term
Ten (10) Local Board Members – Performer*	2-year term
Ten (10) Convention Delegates	2-year term

**The Performer category includes all member categories other than Broadcast, i.e., Actor/Performer, Dancer, Recording Artist, Singer and Stunt Performer. The Broadcast category includes the member categories of Broadcast-Entertainment and Broadcast-News/Information.*

Those members elected as President, Vice President, Recording Secretary, Local Board Members and Convention Delegates, by virtue of their election to those positions, also will be elected as Alternate National Board Members who may be called upon to serve at National Board Meetings when the National Board member from San Francisco-Northern California is unable to attend. The Local Officers shall also serve on the Local Executive Committee and Organizing Committee. The National Board Member, President, Vice Presidents and Recording Secretary, by virtue of their election to those positions, also serve as Convention Delegates. National Board, Local Board and Local Officer candidates must reside within the jurisdiction of the local for a minimum of one (1) year at the time of nomination and throughout their term.

Members may run by petition for any of these positions. Nominating petitions and election materials will be made available online in the member section of the SAG-AFTRA website beginning on Wednesday, May 21, 2025 at www.sagaftra.org/elections or they may be obtained offline by a request in writing via email to sfncelections@sagaftra.org. Petitions must be signed by no fewer than seven (7) San Francisco-Northern California Local members in good standing and received electronically through the online nominating portal **or** offline via email to sfncelections@sagaftra.org no later than Friday, June 20, 2025 at 5 P.M. (PDT). Additional requirements for the submission of nominating materials will be described online and offline in the SAG-AFTRA nominating petition instruction kit.

Once the nominating period has closed on June 20, a candidate may not revoke their consent to serve.

Ballots mailed*

**If candidates run unopposed, they will be declared elected and ballots will not be required.*

SUMMARY OF ELIGIBILITY REQUIREMENTS

All candidates must meet the eligibility requirements established by Article VIII of the SAG-AFTRA Constitution, Article II.C of the Nominations & Elections Policy, and the San Francisco-Northern California Local Constitution which include the following:

National Board Member

- Must be at least 18 years old upon taking office and be a member in good standing of the local for twelve (12) months.
- Must be an active member for twenty-four (24) months prior to the date of nomination.
- Must be paid-up from the beginning of the November 2024 and May 2025 dues periods as reflected in the schedule below*.
- For member category positions only, must be a member of that category for twelve (12) months.
- Must reside within the jurisdiction of the local for a minimum of one (1) year at the time of nomination.

Local Officer or Local Board Member

- Must be at least 18 years old upon taking office and be a member in good standing of the local for twelve (12) months.
- Must be paid-up from the beginning of the November 2024 and May 2025 dues periods as reflected in the schedule below*.
- For member category positions only, must be a member of that category for twelve (12) months.
- Must reside within the jurisdiction of the local for a minimum of one (1) year at the time of nomination.

Convention Delegates

- Must be at least 18 years old upon taking office and a member in good standing of the local for six (6) months.
- Must be paid-up from the beginning of the May 2025 dues period as reflected in the schedule below*.

*Where applicable, members must be in compliance with the Interactive Media Agreement Dues Relief Payment Program to be eligible to vote, or run for office. Request for the May 2025 Interactive Media Agreement Dues Relief Program and 1st installment payment must have been received on or before 6/9/25 (or date of nomination, whichever comes first).
